



PSA member pharmacists - self-recording Group 1 CPD points when attending sessions at the FIP congress.

Sessions at the FIP World Congress can be self-recorded for Group 1 CPD credits to meet the Pharmacy Board of Australia's annual CPD requirements for renewal of registration. Australian registered pharmacists are required to complete 40 CPD credits for the 12-month CPD period ending 30 September each year.

What are Group 1 CPD Credits?

Group 1 CPD credits are attained when accessing information without assessment. Group 1 CPD credits can be accrued by attending presentations and activities with little attendee interaction. Group 1 CPD activities qualify for one Pharmacy Board of Australia CPD credit per hour of activity. 20 out of the 40 required annual CPD credits can be attained from Group 1 activities and the remaining 20 must be attained from Group 2 and/or Group 3 activities.

CPD plan

Commitment to professional development and practice improvement is evident through a pharmacist's approach to lifelong learning. It is important that pharmacists undertake CPD activities that are relevant to their scope of practice and address their needs as documented in a continuing professional development (CPD) plan.

A CPD plan is devised through self-reflection against the National Competency Standards Framework for Pharmacists in Australia, and identification of knowledge gaps that need to be addressed through engaging in CPD activities. A CPD plan is a living document that should be regularly reviewed and amended, for example to include additional needs as they arise, to ensure that professional development needs are being met.

Self-recording Group 1 CPD credits as a PSA member

The PSA offers members a personalised CPD experience through the MyPSA portal. PSA CPD activities that members complete are automatically recorded in their CPD Plan. FIP conference delegates can self-record Group 1 CPD credits for sessions that meet their proposed self-directed learning goals based on their area of practice. Using the MyPSA portal, members can self- record non-PSA CPD activities using the self-record form, and this gets added to their CPD Plan. This is exemplified visually in the instructions below:





1. Log in to your PSA account and navigate to 'My CPD year'. Select '04-Self Record'.

2. Fill out the relevant sections in the online form that appears.
